During January 2017, the industrial producer price index registered a decrease of 1.01 per cent when compared to January 2016.

Industrial Producer Price Indices: January 2017

Annual comparison

When compared to January 2016, the industrial producer price index went down by 1.01 per cent. This was due to a drop of 2.93 per cent in intermediate goods. This decrease was mitigated by an increase of 0.68 per cent in consumer goods and by 0.65 per cent within capital goods. No price changes occurred in the energy sector.

Producer prices for the domestic market increased by 2.42 per cent. Price increases were recorded in the industrial sectors of consumer goods (5.74 per cent) and intermediate goods (1.55 per cent). No changes occurred within energy or capital goods.

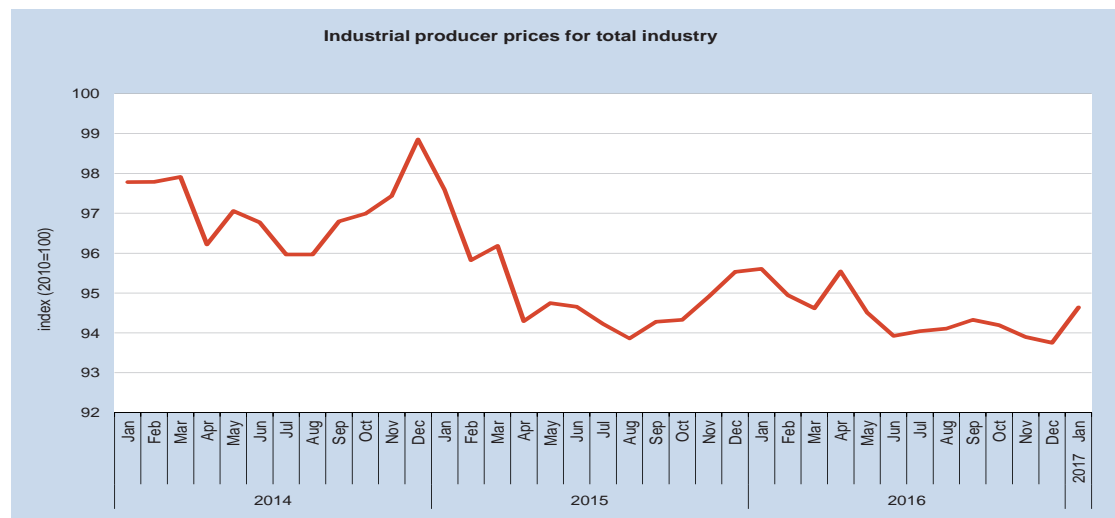
Non-domestic prices fell by 3.39 per cent due to decreases of 3.67 per cent within the non-euro area and 2.90 per cent within the euro area (Table 2).

Monthly comparison

During January 2017, the producer price index for total industry increased by 0.95 per cent over the previous month. This was due to a rise in the prices of consumer goods (2.69 per cent), capital goods (0.63 per cent) and intermediate goods (0.02 per cent). No changes were registered in the energy sector.

Domestic market prices rose by 2.25 per cent due to an increase of 5.56 per cent within consumer goods and 1.16 per cent within intermediate goods. No variations were registered in the energy and capital goods sectors.

Prices for the non-domestic market increased by 0.02 per cent due to a rise of 0.42 per cent in the euro area prices. This was mitigated by a drop of 0.22 per cent within the non-euro area (Table 3) ■

Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of 83 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area are considered domestic. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions among resident enterprises are considered "domestic".
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised.
7. The figures in this news release are unadjusted.
