OF EXPENDITURE FOR 1934-35 AND 1936-37.

Principal reason of Increase or Decrease

Interest and burthens remaining unclaimed.

Grant of new pensions and gratuities.

Mainly due to expenditure in connection with Jubilee festivities.

Increase of staff.

Mainly due to the purchase of a linotype machine.

Principally due to non-recurrent extraordinary expenditure in 1934-35.

Increase of staff due to the introduction of certain amendments in the Laws of Procedure.

Mainly due to providing presses for Archives and to compilation of Indexes.

Revision of salaries of Officers, replacement of waterproofs and purchase of a fire-engine.

Increased price of flour.

Increase in staff and periodical increments.

Normal expansion of the Department, including also revised rates of wages and periodical increments and higher prices of certain commodities.

Increased staff in the Lyceum, periodical increments and development of technical education.

Mainly due to the increase in the number of circulating libraries.

Mainly due to extraordinary works not completed during the year.

Mainly due to the transfer from another Head of the provision for the relief and repatriation of distressed Maltese abroad.

General expansion of the experimental farms.

Due to the adjustment in payments of transit charges for the years 1932-34 made in 1934-35.

Extraordinary works included under another Head of Expenditure.

Mainly due to expenses in connection with His Majesty's Jubilee and acquisition of rural property from the War Department.

New appointments and periodical increments.

Increased maintenance works.

General expansion of the Department.

More extraordinary works carried out.

Expenditure out of Imperial funds for services in connection with the development of agriculture.
