The Council of Government was created by the Congress of 1789
to exercise a great power in administering the affairs of the
United States. It was composed of the Secretary of State and
the members of the Council of State. The Council of State was
composed of the President, the Vice President, and the
Justices of the Supreme Court. The Council of Government
was the highest executive authority in the United States
at that time. It was responsible for the execution of the
laws of the United States and for the management of the
affairs of the United States. The Council of Government
was abolished in 1800 and replaced by the Executive
Department.

The Council of Government was created for the purpose of assisting the Governor or Lieut. Governor in administering the Affairs of the Island of Malta by instructions under the Royal Signet and Sign manual, bearing date the 1st day of April 1835, in the Fifth Year of the Reign of His Late Majesty, and re-constituted by instructions under the Royal Signet and Sign Manual bearing date the 1st day of November 1838, in the Second Year of the Reign of Her Present Majesty. The Members are authorized to assume the adjunctive Style of Honorable.
