Labour Market

Gainfully Occupied Population: August 2005

Labour market data for August 2005, provided by the Employment and Training Corporation (ETC), indicate a drop of 61 persons in the labour supply over the same month in the preceding year. This drop was the result of an increase of 715 persons in the gainfully occupied population and a drop of 776 persons on the unemployment register.

Full-Time Employment

The data on hand indicates that, as from August 2004 to August 2005, the following economic activities within the production sector reported a drop in terms of full-time employment: manufacturing of wearing apparel (-155 persons); manufacturing of radio, television and communication equipment and apparatus (-130 persons); manufacturing of footwear (-98 persons); collection, purification and distribution of water (-97 persons); and, manufacturing of food products and beverages (-44 persons). On the other hand, textile manufacturing reported an increase in employment in the twelve months to August 2005 (+23 persons). On its part, the construction sector reported an increase of 293 persons in employment when compared to the same month in the preceding year.

When it comes to the services sector, as from August 2004 to August 2005, the following economic activities reported an increase in terms of full-time employment: education services (361 persons); wholesale trade (244 persons); the sale, maintenance and repair of motor vehicles and motorcycles and the sale of automotive fuel (159 persons) On the other hand, hotels and restaurants reported a drop of 240 persons in employment in the twelve months to August 2005.

Part-Time Employment

In regard to part-time employment, the ETC figures for August 2005 indicate that the total amount of people with a part-time job went up by 3,164 over the same month in the preceding year. This global figure translates into 1,930 persons whose part-time job is the primary occupation and 1,234 persons whose part-time job is their secondary occupation.

Within the production sector, as from August 2004 to August 2005, the main increases occurred in the manufacture of food products and beverages (+63 persons) publishing, printing and reproduction of recorded media (+36 persons) and construction (+61 persons).

When it comes to the services sector, a growth in part-time employment occurred in the following economic activities: hotels and restaurants (+471 persons); post and telecommunications (+177) education services (+95 persons) and wholesale trade (+379 persons) ■

Methodological Notes

1. In line with international methodology, annual data are being presented as an average for each respective year.
2. The statistics in this release are based on the administrative records of the Employment and Training Corporation (ETC).
3. The data in this release are to be considered as current and therefore subject to revision. Monthly data are revised in T+12.
4. Full / part-time status is defined by what the employer (employer or self-employed) declares in the Engagement Form which is required to be sent to the ETC upon the commencement of employment.

Definitions

Part 1 of the unemployment register: Those registering under Part 1 are either new job seekers who have left school, re-entrants into the labour market, and job losers who have been made redundant by their former employer.

Part 2 of the unemployment register: Those registering under Part 2 are either workers who have been dismissed from work due to disciplinary action, left work out of their own free will, refused work or training opportunities or were struck off the register after an inspection by the Law Enforcement personnel.
