Transport

Motor Vehicles: July-September 2008

The stock of licensed motor vehicles rose by 2,235 in the third quarter of 2008, to stand at 294,155.

As at end September 2008, the stock of licensed motor vehicles stood at 294,155. Of these, 75.8 per cent were private vehicles while commercial vehicles accounted for 16.3 per cent (see Table 1).

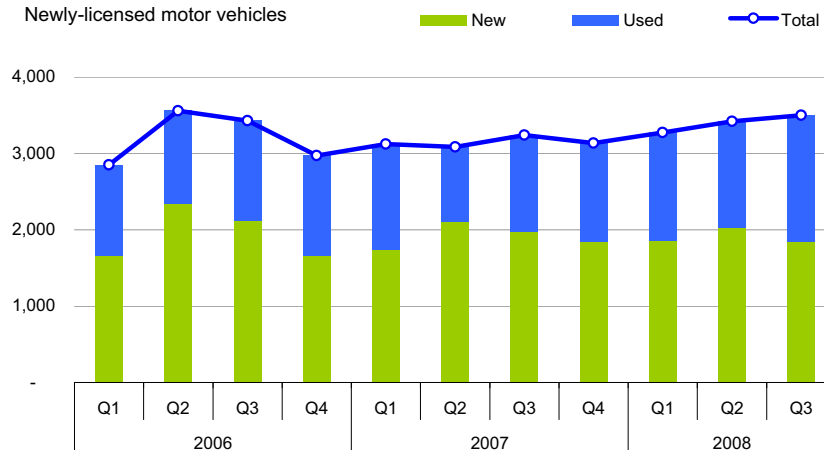
New licences

New licences issued during the third quarter of 2008 amounted to 3,501. Private vehicles accounted for 2,438 new licences, or 69.6 per cent of the total. In the reference quarter, the majority of new licences were issued to private vehicles falling within 'Class 1' (<1300 cc). This class accounted for 1,446 new licences, while vehicles in 'Class 2' (1301-1449 cc) accounted for 339. Newly-licensed 'new' motor vehicles amounted to 1,851, or 52.9 per cent of the total, while newly-licensed 'used' motor vehicles amounted to 1,650 (see Tables 3-4).

Exported, scrapped and garaged

In the third quarter of 2008, 32 vehicles were exported. Scrapped vehicles numbered 697, of which 88.1 per cent were 'Class 1' private cars (<1300 cc). In the period under review, 1,299 vehicles were garaged (see definitions on page 7). This means that as at end September, garaged vehicles accounted for nearly 66 per cent of total vehicles that are no longer on the road ■

Methodological Notes

1. This News Release is based on data provided by the Malta Transport Authority
2. Data are final and are not normally subject to revision
3. **Definitions:**

Agricultural	Motor vehicle, normally a tractor, designed exclusively or primarily for agricultural purposes; licensed to use roads open to public traffic.												
Coach and private bus	Passenger road motor vehicle designed to seat more than 18 persons (including the driver).												
Commercial vehicle	Road vehicle designed, exclusively or primarily, to carry goods. This category includes also leased motor vehicles.												
G/Hire	Chauffeur-driven car for hire.												
Minibus	Passenger road motor vehicle designed to seat up to 18 persons (including the driver).												
Motorcycle	Two-wheeled road motor vehicle with or without side-car, including motor scooter, or three-wheeled road motor vehicle.												
Private vehicle	Road motor vehicle, other than a motorcycle, intended for the carriage of passengers and designed to seat up to nine persons. This category is sub-divided into further classes according to engine capacity: <table><tr><td>Class 1:</td><td>< 1300 cc</td></tr><tr><td>Class 2:</td><td>1301 - 1449 cc</td></tr><tr><td>Class 3:</td><td>1450 - 1500 cc</td></tr><tr><td>Class 4:</td><td>1501 - 1800 cc</td></tr><tr><td>Class 5:</td><td>1801 - 2000 cc</td></tr><tr><td>Class 6:</td><td>> 2000 cc</td></tr></table>	Class 1:	< 1300 cc	Class 2:	1301 - 1449 cc	Class 3:	1450 - 1500 cc	Class 4:	1501 - 1800 cc	Class 5:	1801 - 2000 cc	Class 6:	> 2000 cc

Electric car	Electrically operated car, totally independent of fuel-driven engine.

Self-drive motorcycle	Same as motorcycle above, available for hire.												
Taxi	Passenger road motor vehicle available for hire (with chauffeur).												
Semi-trailer	Goods road vehicle with no front axle which is designed to be hauled by a road motor tractor, which also carries a substantial part of the loaded weight. Semi-trailers are excluded from the total in the accompanying tables as these are not self-propelled.												
Leased	A contract under which the owner of a motor vehicle grants to another person the exclusive possession of the motor vehicle for an agreed period, in return for a consideration, and under such conditions that the possessor of the motor vehicle will be obliged to pay the full amount of the consideration, or a penalty, to the owner of the motor vehicle, should the contract be terminated before the expiration of the agreed period. A QZ plate is assigned to all vehicles falling in the leased category.												
Garaged	Vehicles no longer licensed for use on the road, but exclude vehicles which have been scrapped or exported.
