Provisional data indicate that the industrial producer price index in July decreased by 0.74 per cent over the previous month.

Monthly comparison

During July, the producer price index for total industry decreased by 0.74 per cent to 95.11 points. The most significant decrease was in the intermediate goods sector, where prices went down by 1.83 per cent. On the other hand, consumer goods rose by 0.23 per cent, whereas the energy and capital goods sectors remained constant.

Prices within the domestic market edged down by 0.01 per cent, on account of a decline in prices within consumer goods. The other sectors remained constant.

Prices for the non-domestic market decreased by 1.28 per cent, as prices in respect of goods destined for the non-euro area and euro area declined by 1.47 and 0.95 per cent respectively.

Annual comparison

On an annual basis, the industrial producer price index decreased by 2.74 per cent. The downturn resulted from price decreases in energy (-6.98 per cent), intermediate goods (-2.97 per cent), and consumer goods (-2.01 per cent). However, prices for capital goods increased by 1.32 per cent.

Producer prices for the domestic market decreased by 1.83 per cent, mainly on account of a drop in the producer prices of the energy sector. In contrast, price increases of 3.06 and 0.75 per cent were recorded in capital and consumer goods respectively.

During the period under review, non-domestic prices decreased by 3.40 per cent, resulting from declines of 4.67 and 1.21 per cent within the non-euro and euro area respectively ■

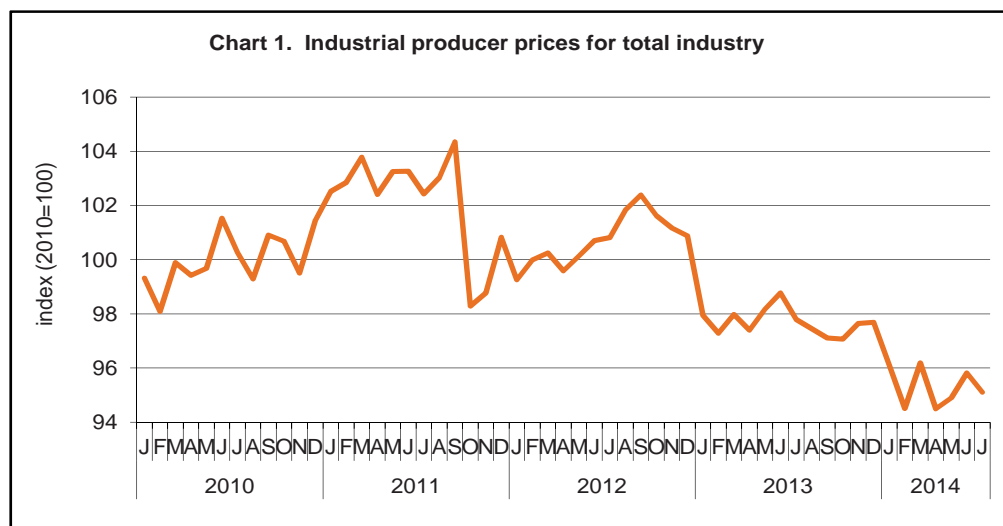

Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of 83 large enterprises which account for over 80 per cent of the total industrial turnover.
2. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised. The figures in this news release are unadjusted.
3. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
4. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
5. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area were considered. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions between resident enterprises are considered "domestic".
6. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, water, and energy sectors.
