

Provisional data indicate that the industrial producer price index in July 2016 increased by 0.33 per cent when compared to the corresponding month in previous year.

Industrial Producer Price Indices: July 2016

Cut-off date:
22 August 2016

Annual comparison

On an annual basis, the industrial producer price index went up by 0.33 per cent when compared to 2015. This was due to an increase in prices within capital goods (0.71 per cent), consumer goods (0.50 per cent) and intermediate goods (0.20 per cent). No price changes occurred in the energy sector.

Producer prices for the domestic market increased by 0.92 per cent. Price increases were recorded in intermediate goods (1.37 per cent), consumer goods (1.25 per cent) and capital goods (1.10 per cent).

Non-domestic prices decreased by 0.07 per cent, resulting from a drop in prices of 0.19 per cent within the euro area and 0.01 per cent within the non-euro area (Table 2).

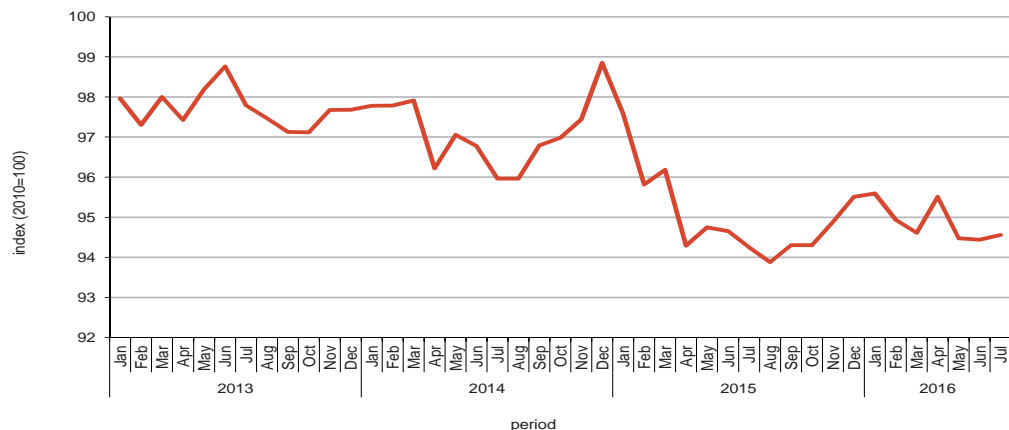
Monthly comparison

During July the producer price index for total industry increased by 0.13 per cent when compared to the previous month. Prices went up for intermediate goods (0.24 per cent), capital goods (0.15 per cent) and consumer goods (0.01 per cent).

Domestic market prices increased by 0.04 per cent. This was due to a rise of 0.43 per cent within capital goods but mitigated by a drop of 0.02 per cent in the consumer goods sector.

Prices for the non-domestic market increased by 0.19 per cent. This was due to a rise of 0.13 per cent in the prices within the euro area and of 0.23 per cent within the non-euro area (Table 3) ■

Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of 83 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area are considered domestic. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions among resident enterprises are considered "domestic".
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised.
7. The figures in this news release are unadjusted.
