

During June 2017, the industrial producer price index registered an increase of 1.29 per cent when compared to the same month last year.

## Industrial Producer Price Indices: June 2017

Cut-off date: **Annual comparison**  
21 July 2017

When compared to June 2016, the industrial producer price index went up by 1.29 per cent. This was due to a rise of 2.32 per cent in intermediate goods, 0.99 per cent in capital goods and by 0.47 per cent in consumer goods. No price changes occurred in the energy sector.

Industrial producer prices for the domestic market increased by 0.75 per cent. Price increases were recorded within intermediate goods (1.44 per cent), consumer goods (0.91 per cent) and capital goods (0.43 per cent).

Non-domestic prices increased by 1.65 per cent due to a rise in prices of 1.75 per cent within the non-euro area and 1.53 per cent within the euro area (Table 2).

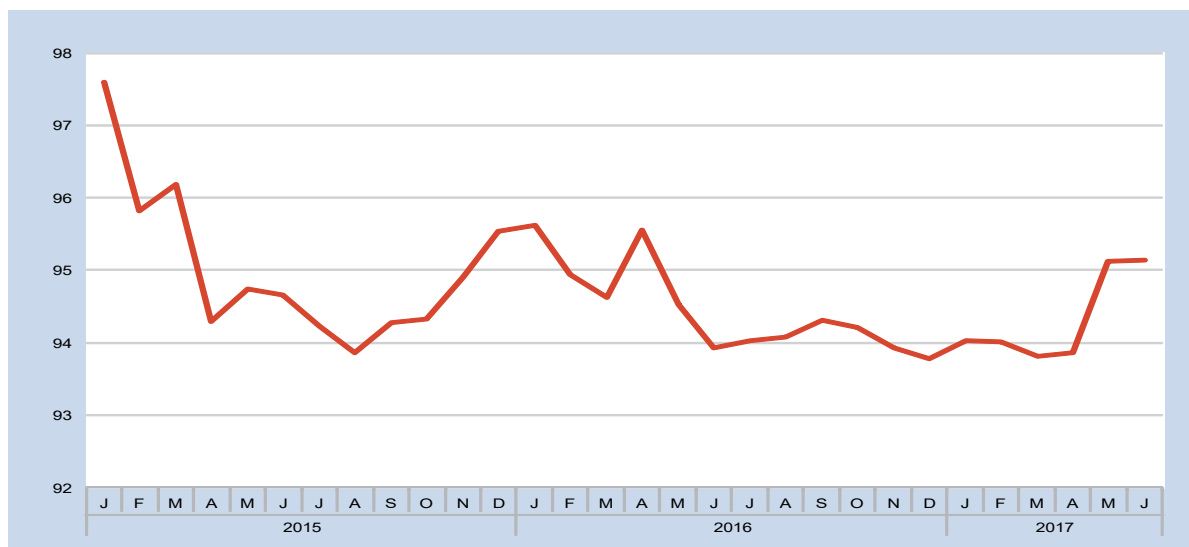
### Monthly comparison

During June 2017, the producer price index for total industry registered a slight increase of 0.02 per cent over the previous month. This was due to an increase in prices of intermediate goods (0.22 per cent) that was almost completely mitigated by a decrease in prices within consumer goods (0.24 per cent). No changes were registered in the energy and capital goods sectors.

Domestic market prices registered a marginal increase of 0.01 per cent due to a rise in prices of 0.04 per cent within the consumer goods category.

Prices for the non-domestic market increased by 0.03 per cent. This has emanated from a rise of 0.06 per cent in the non-euro area that was mitigated by a drop in prices of 0.03 per cent within the euro area (Table 3) ■

## Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of 83 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area are considered domestic. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions among resident enterprises are considered "domestic".
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised.
7. The figures in this news release are unadjusted.
