

During April 2018, the industrial producer price index registered an increase of 6.62 per cent when compared to the same month last year.

## Industrial Producer Price Indices: April 2018

Cut-off date:  
25 May 2018

### Annual comparison

When compared to April 2017, the industrial producer price index went up by 6.62 per cent. This resulted from a rise of 19.19 per cent in the intermediate goods sector. Decreases were registered in the consumer goods (0.75 per cent) and capital goods (0.08 per cent) sectors. No price changes occurred in the energy sector.

Industrial producer prices for the domestic market increased by 0.14 per cent. Price rises were recorded within consumer goods (1.60 per cent) and intermediate goods (0.18 per cent) while price drops were registered in the capital goods sector (1.33 per cent).

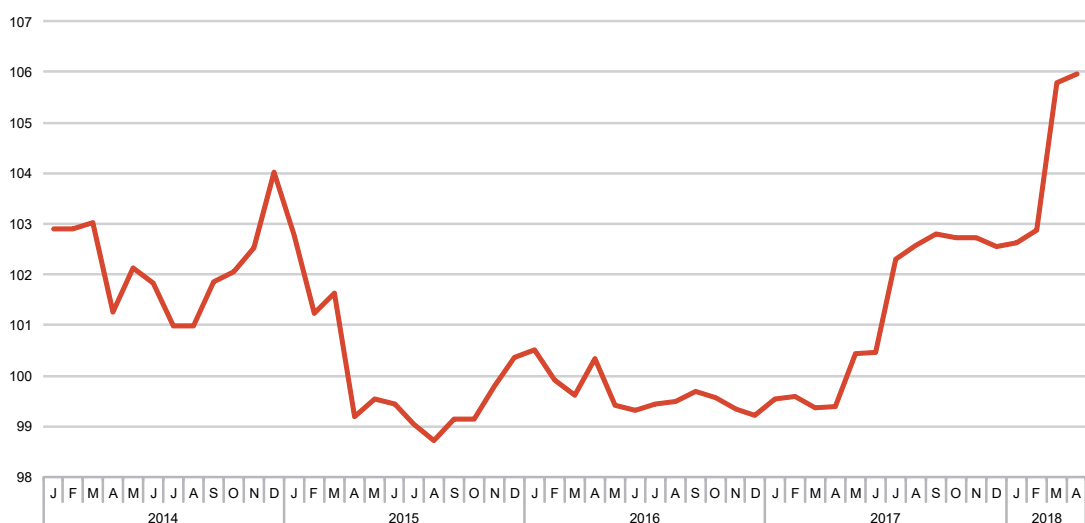
Non-domestic prices increased by 11.39 per cent due to a rise of 14.62 per cent within the non-euro area and 5.53 per cent within the euro area (Table 2).

### Monthly comparison

During April 2018, the producer price index for total industry registered an increase of 0.17 per cent over the previous month. This was due to a price rise of 0.41 per cent within the intermediate goods sector and 0.06 per cent within the capital goods sector.

No price changes were recorded in the domestic sector while non-domestic prices increased by 0.29 per cent (Table 3) ■

## Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of around 80 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area are considered domestic. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions among resident enterprises are considered "domestic".
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised.
7. The figures in this news release are unadjusted, that is no working-day or seasonal adjustments.
