

During April 2019, the industrial producer price index registered an increase of 1.15 per cent when compared to the same month of the previous year.

Industrial Producer Price Indices: April 2019

Annual comparison

When compared to April 2018, the industrial producer price index went up by 1.15 per cent. This was due to a rise of 1.83 per cent in intermediate goods, 1.45 per cent in consumer goods and 0.06 per cent in capital goods. No price changes were registered within the energy sector.

Industrial producer prices for the domestic market increased by 1.05 per cent. Price rises were recorded within intermediate goods (3.38 per cent) and consumer goods (0.93 per cent). No price changes were recorded in the energy and capital goods sectors.

Non-domestic prices increased by 1.24 per cent due to a rise of 1.75 per cent within the non-euro area and 0.27 per cent within the euro area (Table 2).

Monthly comparison

During April 2019, the producer price index for total industry registered a drop of 0.57 per cent over the previous month. This was due to a price decrease of 1.44 per cent within intermediate goods and mitigated by a rise of 0.05 per cent in the consumer goods sector. There were no changes within the energy and capital goods sectors.

Prices within the domestic market rose by 0.10 per cent, due to a rise of 0.44 per cent in the intermediate goods sector. No other changes were recorded in the other economic sectors.

Non-domestic prices decreased by 1.01 per cent as a result of a decline of 1.28 per cent within the non-euro area and 0.47 per cent in the euro area (Table 3) ■

Chart 1. Industrial producer prices index (2015=100) for total industry

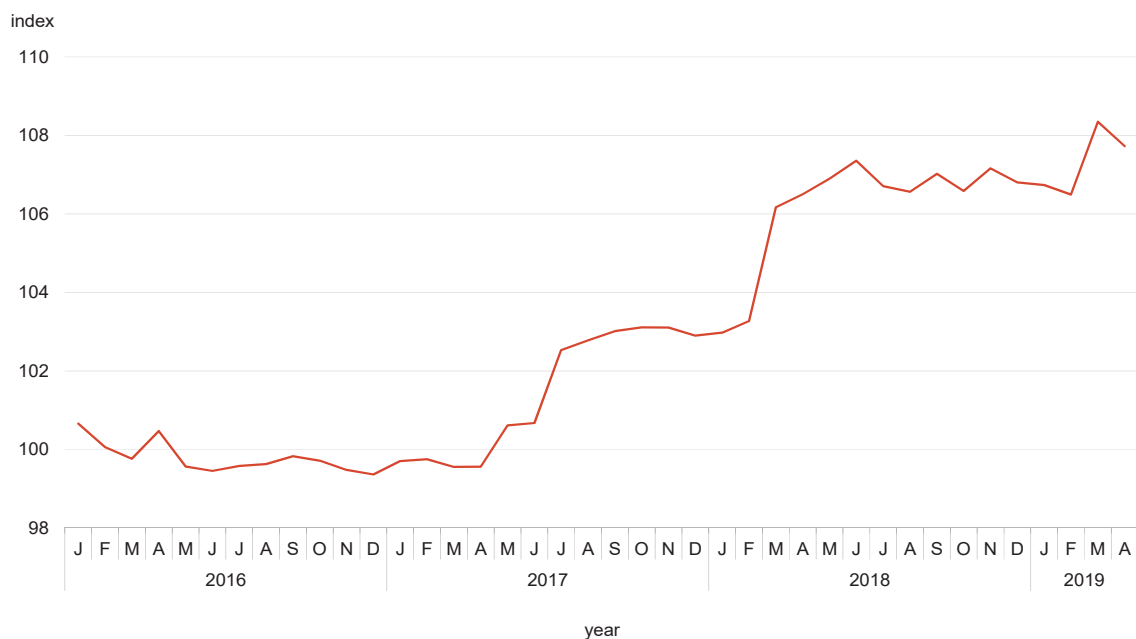

Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of around 80 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. For the purpose of calculating the euro area export figures, only transactions between enterprises in countries within the euro area are considered domestic. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. Transactions among resident enterprises are considered "domestic".
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, back data may also be revised.
7. The figures in this news release are unadjusted, that is, there are no working-day or seasonal adjustments.
