

During September 2020, the industrial producer price index registered a decrease of 0.99 per cent when compared to the same month of the previous year.

Industrial Producer Price Indices: September 2020

Annual comparison

When compared to September 2019, the industrial producer price index dropped by 0.99 per cent. Intermediate goods went down by 3.06 per cent while price increases were registered in consumer goods (0.82 per cent) and capital goods (0.36 per cent). No price change was registered in the energy sector.

Industrial producer prices for the domestic market increased by 1.60 per cent. Price rises were recorded in consumer goods (4.93 per cent), intermediate goods (0.39 per cent) and capital goods (0.22 per cent).

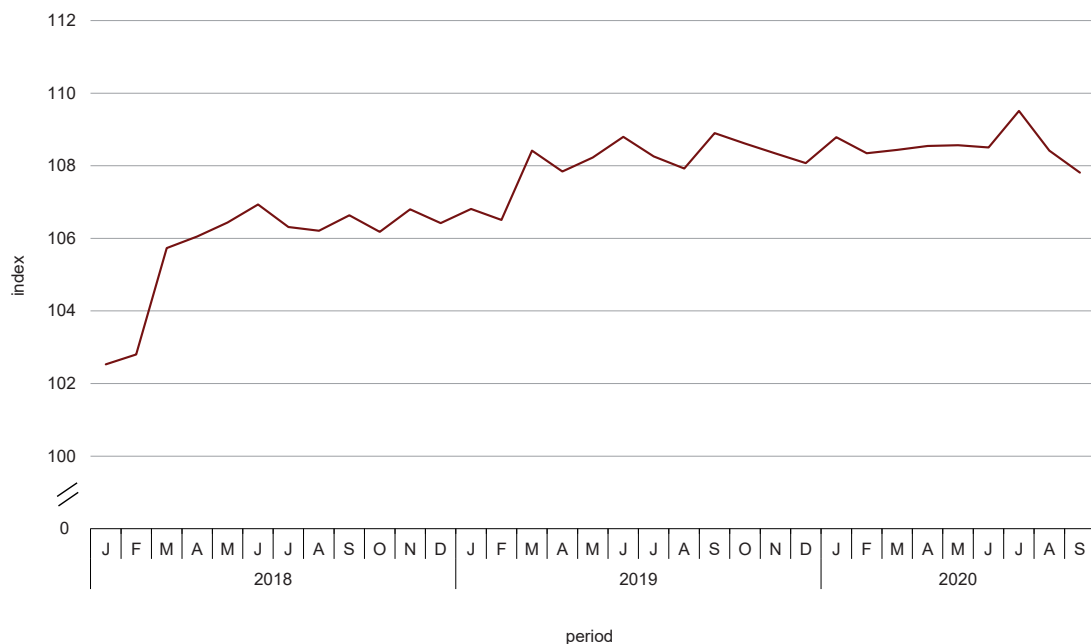
Non-domestic prices decreased by 2.61 per cent. A decrease of 3.85 per cent was registered within the non-euro area while a drop of 0.10 per cent was registered within the euro area (Table 2).

Monthly comparison

During September 2020, the industrial producer price index decreased by 0.56 per cent over the previous month. Price declines were registered in consumer goods (1.06 per cent) and intermediate goods (0.60 per cent). Capital goods went up by 0.02 per cent.

Prices within the domestic market dropped by 0.02 per cent due to a decrease of 0.07 per cent in consumer goods. Non-domestic market prices dropped by 0.90 per cent due to decreases of 1.26 per cent and 0.18 per cent in the non-euro and euro-area zones respectively (Table 3) ■

Methodological Notes

1. The industrial producer price index monitors the changes in selling prices of all leading products within a sample of around 80 large enterprises which account for over 80 per cent of the total industrial turnover.
2. The pricing point for the monthly price collection is the 15th day of the month or the nearest trading day prior to that date.
3. The methodologies and guidelines used are set by Eurostat and the International Monetary Fund (IMF).
4. Euro area exports are transactions between Maltese enterprises and enterprises within the euro area. The euro area includes Austria, Belgium, Cyprus, Estonia (from 2011), Finland, France, Germany, Greece, Ireland, Italy, Latvia (from 2014), Lithuania (from 2015), Luxembourg, the Netherlands, Portugal, Slovakia, Slovenia, and Spain. These are classified as 'non-domestic euro-area'. The 'non-domestic non-euro area' covers transactions between Maltese enterprises and enterprises within the non-euro area. Examples include the USA and Sweden. The latter country is in the EU but does not use the euro currency. Transactions among local resident enterprises are considered 'domestic'.
5. The objective of Main Industrial Groupings (MIGs) is to provide an activity breakdown of industry using the internationally recognised classification of economic activities (NACE Rev. 2 Sections B, C, D and E) in terms of demand-based products: intermediate goods, energy, capital goods, durable consumer goods, and non-durable consumer goods. These regroup NACE Sections B to E and cover the following economic activities: quarrying, manufacturing, electricity and water.
6. Figures for the last three months are to be considered provisional and subject to revision. However, in exceptional cases, past data may also be revised.
7. The figures in this news release are unadjusted, that is, there are no working-day or seasonal adjustments.
